
1. Voltage - 117 volts - 60 cycle - A.C. only.

Use of the MP-3 phono top on other than the specified voltage or frequency will result in improper operation and serious damage which will void the guarantee.

- 2. Pickup High impedance crystal type 1.0 volt output.
- 3. The MP-3 phono top is designed to fit the covers of the following Masco amplifiers:

Audiosphere 27
Audiosphere M-27
Audiosphere 36
Audiosphere 60
Audiosphere 100

- 4. When unpacking the MP-3 phono top, be careful not to discard the paper bag containing two (2) #6 sheet metal screws and two (2) strips of rubber channel, 10-1/8" long. The two screws and rubber channels are used to mount the MP-3 phono top to covers of the amplifiers listed in paragraph #3.
- 5. To mount the MP-3 phono top, fit a piece of rubber channel on each side of the unit. On the front of the unit is a 1/4" lip which fits onto the overhang on the covers of the amplifiers. Slide the MP-3 as far back as possible. When this is done, the two holes on the unit match the two holes on all of the above mentioned amplifier covers. Tighten phono top down with the two (2) #6 screws supplied in the paper bag. Plug the pickup arm lead (shielded wire) into the socket at the rear of the amplifier marked "Phono-Radio". Plug the line cord into the A.C. receptacle, which is also located at the rear of the amplifier. The unit is now ready for operation.
- 6. Select the proper speed and needle to play records.
