AC-DC difference tests are made at C.P.D. Engineering, Inc. on Thermal Voltage converters with the uncertainties shown in the table on the following page. Two factors are stated as follows.

C.P.D.: The AC-DC differences given in the attached certificate are obtained by averaging the results of a series of comparisons between the instrument under test and standards tested by the U.S. National Institute of Standards and Technology. Statistical tests of this data indicate that there is no more than a 1% probability that the value given on this test report will vary from the average of an infinite series of such comparisons by more than the 4R value shown in parts per million designated "CPD" in the table on the following page.

The factor designated "NIST" in the table on the following page is the uncertainty of data reported to C.P.D. by NIST.

This Thermal Voltage Converter was tested during the week of Dec. 16, 1991 to determine AC-DC difference. These determinations were made by comparison against a group of Thermal converters previously tested by NIST and corrected to absolute AC-DC differences. The corrected differences are given in the table below. A positive sign signifies that more alternating voltage was required than the mean of the reversed DC voltages to obtain the same output emf. These differences are taken from the center of a GR874T Connector plugged into the test instrument. The voltage at the front plate of the test instrument may be computed by adding 0.8 x 10^{-4} f² where f is in Megahertz.
